

EGGO™ HOLIDAY CHAOS SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS REQUIRED. VOID WHERE PROHIBITED.

1. PROMOTION DESCRIPTION. The **Eggo™ Holiday Chaos Sweepstakes** (the “**Sweepstakes**”) is an online entry only Sweepstakes that begins on 11/30/23 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 12/20/23 at 11:59:59 PM (ET) (the “**Promotion Period**”). 2. ELIGIBILITY. Open to legal residents of the fifty (50) United States and District of Columbia who are eighteen (18) years of age or older at the time of entry. Thirty Thousand (30,000) First Prizes are available (ten thousand (10,000) First Prizes per Entry Period). First Prize consists of one (1) free **Eggo**® product - to be awarded in the form of **Eggo**® Barcode Buck\$® / ARV \$3.99 each winner. First Prize Barcode Buck\$® expire on 3/31/24.
